1. Call to Order

President Courtney called the meeting to order at 1:33 PM.

2. Roll Call

Present: Courtney, Caen, Moran and Kwon Commissioner Caen arrived at 1:40 PM.

3. Approval of the Minutes of October 23, 2018

4. General Public Comment

 Francisco DaCosta discussed the miles of sewer and water pipes in the system and asked if any pipe is leaking. He addressed the loss of institutional memory due to retirements.

Commissioner Caen arrived at 1:40 PM.

Public Comment (all speaking to item 5f Street Light Program Update)

- Larry Gothberg indicated that residents are still waiting for historic lights to be installed on Hyde Street.
- Simon Bertrang, Tenderloin CBD, expressed excitement for the street lighting project and disappointment at the length of time it is taking. He indicated the lighting is important for business and pedestrian safety. He asked if temporary lighting can be installed until the historic lights arrive.
- Brant de Venecia, Tenderloin Housing Clinic, discussed the history of the lighting project, delays that have taken place, and that temporary lights have not been installed. He demanded 100 poles to be installed immediately.
- Adam Leising, Lower Hyde Street Association, concurred with Mr. de Venecia's comments. He stated the neighborhood feels marginalized with delay of such projects and that action needs to be taken.
- David Elliot Lewis discussed the negative effects of poor or non-existing lighting in the Tenderloin. He expressed the need for temporary lighting for neighborhood safety and security.

- Pralibha discussed numerous project delays and demanded 100 temporary lights be installed.
- Francisco DaCosta stated the Tenderloin needs help and that migration into District 6 needs to be studied. He discussed the importance of lighting for safety. He noted the need for mediation with PG&E.

General Manager (GM) Kelly, Jr. stated he would provide comment on the matter during item 8, Report of the General Manager.

7. Annual Policy and Government Affairs Update

Emily Lam, Director of Policy and Government Affairs, provided the update. She began by thanking colleagues for their work during the year. She then provided highlights of legislative activities as noted in the published report at the local, state, and federal levels.

Public Comment

- Francisco DaCosta suggested a hearing regarding policies. He questioned the subsidy of large organizations such as Salesforce and asked how policies benefit the community.
- Peter Drekmeier, Tuolumne River Trust, discussed the Non-Governmental Organizations (NGOs) letter that was previously submitted and reviewed. He discussed federal policy related to FERC re-licensing and work with the Trump administration. He provided written comment for the record.

Michael Carlin, Deputy General Manager (DGM), stated that the SFPUC has worked on the issue with multiple administrations and career staff throughout the years. He briefly discussed the process and recommendations that have been made.

8. Report of the General Manager

GM Kelly asked Barbara Hale, Assistant General Manager (AGM) Power, to discuss the Tenderloin Street Light Project, item 8b, first.

d) Report on Recent San Francisco Public Utilities Commission Activities, Events and Announcements

AGM Hale acknowledged the frustrations of the community regarding project delays. She noted there was a competitive bidding process and delivery of faulty product. She stated new product was to be delivered October 5th, but she was told by the manufacturer there were fitting problems with the product. She stated temporary lighting was taken from existing stock, resulting in two temporary lights per block. She indicated the manufacturer is expected to provide details on delivery of new product by close of business October 23rd. She stated once the delivery date is known, a schedule of temporary lighting will be determined.

AGM Hale responded to a question from GM Kelly, Jr. about purchasing additional temporary lighting.

President Courtney requested a status update at future Commission meetings.

Commissioner Moran asked AGM Hale to research if there are extra cobra lights that can be purchased from other cities.

AGM Hale responded to question from Commissioner Kwon regarding the installation timeline.

No public comment.

a) CleanPowerSF Update

AGM Hale provided the update: (1) Enrollment and Service to Customers: Currently serving 108,000 accounts; 3.1% opt-out rate; 3.6% SuperGreen upgrade rate; (2) Regulatory: California Public Utilities Commission (CPUC) is reconsidering the methodology as to how the PCIA (exit fee) set. AGM Hale indicated the CPUC had two proposals for consideration, one by the judge and one by the Commissioner assigned (alternate), and that on October 11th the CPUC voted unanimously to approve alternate proposal. She stated the Community Choice Aggregation (CCA) community opposes the alternate proposal as it underestimates the market value of PG&E generation resources, which results in more of PG&E costs being recovered through the exit fees charged to CleanPowerSF customers. She stated it also unlawfully allows above-market costs of generation assets that are owned by PG&E to be recovered by the exit fee. She stated with the decision, the exit fee will have increased by more than 200% since the San Francisco committed to CCA service in 2015.

AGM Hale anticipates the proposal will be implemented January 1, 2019 and estimates that CleanPowerSF customers could pay \$40M to \$50M more per year, and that the typical residential customer will experience a \$1.50 - \$2.50 monthly bill increase if no action taken by SFPUC. She indicated an update to PG&E rates is expected at the beginning of November, which could alter numbers she presented. She noted possible next steps.

Commissioner Moran stated the business risk was known. He requested an analysis of the impact on Power Enterprise (CCA) financials and an analysis of long-term effects on the business model.

Public Comment

Francisco DaCosta questioned how many electrical lines from Hetch
Hetchy come under the jurisdiction of the SFPUC and why the SFPUC
continues to have special agreements with PG&E for service to the City.

Commissioner Moran stated it is an old but interesting issue on transmission into the City. He asked that staff review to see if changing economics changes outcomes of analysis. He stated that PG&E doesn't control the transmission lines anymore, but that Cal ISO now does. He requested an update on options for local distribution and transmission.

b) Bay Delta Water Quality Control Plan Update

Ellen Levin, Deputy Manager, Water, recapped a meeting held with staff and the NGOs to discuss their concerns as expressed in their previously provided letter to the Commission.

DGM Carlin discussed a Board of Supervisors resolution submitted by Supervisor Peskin urging the Board to support the State Board's Plan. He indicated staff has met with the Supervisor and continue to work with him on the issue. He stated the resolution will be before the Land Use Committee on October 29.

Public Comment

- Peter Drekmeier, Tuolumne River Trust, discussed his 2017 Sunshine request for information for communication between SFPUC staff, lobbyists, and various elected officials.
- Francisco DaCosta discussed the Bay Delta Plan and activities that have taken place.
- c) Workforce Development Update: New Employee Orientation
 Cindy Charan, Director, SFPUC Human Resource Services, provided an
 update regarding AB119 and requirements for new employee orientation
 (NEO) and the City's Department of Human Resources and SFPUC's actions
 for compliance: regular and recurring NEO sessions; provide annual notice
 to unions as to the NEO schedule; provide unions with notice of NEO
 enrollment; provide 30-minutes of access for union representatives to meet
 with employees at NEO; provide new employees with a union notification
 document; and MOU link provided to employees and paper copies provided.

9. Bay Area Water Service Conservation Agency (BAWSCA) Update
Nicole Sandkulla, CEO, BAWSCA, noted BAWSCA's August 2018 total potable
water use 17% less than August 2013. She stated BAWSCA is moving forward
with a demand study for the service area and that the scope is being developed
and the RFP is being prepared. She noted it will take approximately one year to
complete the study.

Commissioner Moran thanked Ms. Sandkulla for the information and that he looks forward to the study.
