**CEQA Appeal Rights under Chapter 31 of the San Francisco Administrative Code**: If the Commission's action on a project constitutes the Approval Action for that project (as defined in S.F. Administrative Code Chapter 31, as amended, Board of Supervisors Ordinance Number 161-13), then the CEQA determination prepared in support of that Approval Action is thereafter subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16. Typically, an appeal must be filed within 30 calendar days of the Approval Action for a project that has received an exemption or negative declaration pursuant to CEQA. For information on filing an appeal under Chapter 31, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. If the Planning Department's Environmental Review Officer has deemed a project to be exempt from further environmental review, an exemption determination has been prepared and can be obtained on-line at <a href="http://www.sf-planning.org/index.aspx?page=3447">http://www.sf-planning.org/index.aspx?page=3447</a>. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors, Planning Commission, Planning Department or San Francisco Public Utilities Commission at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.

a) Approve <u>Amendment No. 2 to Contract No. PRO.0165</u>, PUC As-Needed Lab Analytical (Contract), with Eurofins Eaton Analytical, LLC, increasing the contract amount by \$1,800,000 and extending the contract duration by four years, for total not-to-exceed contract amount of \$6,300,000 and a total contract duration of nine years, to provide for continued specialized analytical services to meet current and new regulatory compliance requirements with the California State Water Resources Control Board and other regulatory agencies.

- c) Accept work performed by Ranger Pipelines Inc., under <u>Contract No. WD-2890R</u>, Bay Division Pipeline Nos. 3 and 4 Slip Lining at Lafayette Street, for a total contract amount of \$5,818,356 and a total contract duration of 379 consecutive calendar days; and authorize final payment to the contractor. - d) Award Job Order <u>Contract No. JOC-107</u>, General Engineering (A License) Construction, Micro-LBE Set-Aside, San Francisco, San Mateo, Santa Clara, and Alameda Counties, in the amount not-to-exceed \$2,000,000, with a guaranteed minimum task order opportunity amount of \$50,000, and a duration of two years, to the sole responsible bidder that submitted a responsive bid, Angotti & Reilly, Inc., to perform A licensed general engineering construction work on San Francisco Public Utilities Commission systems and operations around the Bay Area. (Robinson)
- e) Award Job Order <u>Contract No. JOC-108</u>, General Engineering (A License) Construction, San Francisco, San Mateo, Santa Clara, and Alameda Counties, in the amount not-to-exceed \$5,000,000, with a guaranteed minimum task order opportunity amount of \$50,000, and a duration of two years, to the sole responsible bidder that submitted a responsive bid, Anvil

Builders Inc., to perform A licensed general engineering construction work on San Francisco Public Utilities Commission systems and operations around the Bay Area. (Robinson)

- f) Accept work performed by Cal State Constructors under <u>Contract No. WD-2871</u>, Sunol Valley Water Treatment Plant and Chlorination Facility Aqua Ammonia Structural Repairs and Tank Replacement, for a total contract amount of \$2,045,523 and a total contract duration of 787 consecutive calendar days; and authorize final payment to contractor. - g) Award <u>Contract No. WW-747</u>, Seacliff Avenue Pump Station & Force Main Upgrade and Seacliff 1 Pump Station Demolition to the responsible bidder that submitted the lowest responsive bid, Minerva Construction, Inc., in the amount of \$5,777,000, and with a duration of 560 consecutive calendar days (approximately one year and seven months), to replace the existing Seacliff 1 Pump Station with a new underground pump station located on Seacliff Avenue. This action constitutes the Approval Action for the Project for the purposes of the California Environmental Quality Act (CEQA), pursuant to San Francisco Administrative Code section 31.04(h). The Planning Department has determined that the Project is exempt from the CEQA. The Commission will rely on that determination to make its decision on this action. (Robinson)
