Project Scope



Sewer

Approximately 1.4 miles of sewer main rehabilitation or replacement



Water

Approximately 6.7 miles of water main replacement



Fiber

1.5 miles of fiber optic conduit upgrades




Geary Boulevard Utility Upgrades

Location: Geary Boulevard between 32nd Avenue and Stanyan Street

Work Segments:

- Segment A: 32nd Avenue to 12th Avenue
- Segment B: 12th Avenue to Stanyan Street






Importance of Upgrading Geary Water & Sewer Infrastructure

Aging Infrastructure

- Most sewer and water mains in the project area are over 120 years old
- Installed in the late 1800's for the early development of the Richmond District







Importance of Upgrading Geary Water & Sewer Infrastructure

Bookend water mains already upgraded

 Completed in 2021: 48th to 32nd Avenue and Presidio Avenue to Kearny Street






'Dig Once' Approach

- Coordinating our work with SFMTA's planned surface improvements
- Minimizes disruptions to the community
- Maximizes City resources by combining efforts into major projects

What to Expect During Construction





- Work will be done in phases
- Construction activity will be intermittent
- Expect for crews to finish a portion of work on a block and then return later to work on a different aspect of work
- Excavated areas will be temporarily paved
- Final paving will occur as part of the separate Transit and Safety Surface Improvements contract



What to Expect During Construction

NO STO	OPPING

Parking

- Temporarily prohibited in active construction zones
- Most restrictions during construction working hours only
- Some spaces will be used to stage materials and equipment

Traffic

- Vehicle and bus traffic will be maintained in both directions
- Two travel lanes will be open in both directions (in most cases)



What to Expect During Construction

Access

- Driveway access will be maintained, though there may be slight delays*
- Sidewalk access will be maintained, however modified walkways may sometimes be necessary

* Individual coordination will be done with businesses that require frequent access throughout the day.

Construction Impacts

 Noise, dust, and vibrations in active work zones

Services Offered to Merchants

Office of Economic and Workforce Development (OEWD)

- OEWD has partnered with SFMTA and SFPUC on this project to provide business support to small business owners as they navigate through construction projects.
- Jada Jackson manages the OEWD Small Business Construction Mitigation Program and will serve as a business liaison/point of contact for business support services and technical assistance.


- Business Accounting/Budgeting
