



Irrigation Controller Rebate Program

Property Owner's Notice and Release

Congratulations, your water-conscious tenant located at _____, is applying for the San Francisco Public Utilities Commission (SFPUC) **Irrigation Controller Rebate Program**. To help reduce potable water use for landscape irrigation, this program provides rebates on irrigation controllers, soil-moisture sensors, and add-on devices (Devices) for SFPUC water service customers. Eligible participants can receive rebates up to \$250 per controller (limit 2), **or** \$35 per active station on controllers for large irrigation systems that are WaterSense labeled from the U.S. Environmental Protection Agency.

Terms and Conditions

The undersigned Owner is participating in the SFPUC Irrigation Controller Rebate Program, under which SFPUC will provide a rebate for the purchase of eligible Devices. Participants in the program agree to install and program their rebated Devices according to the manufacturer's instructions.

Indemnification of City and County of San Francisco

I (Owner) hereby certify I am the legal owner of the property that is being served as a retail customer of the San Francisco Public Utilities Commission where an eligible Device will be installed. I agree that the SFPUC may inspect the installed Device(s); and that installation may not result in lower water bills; and that the SFPUC does not warrant any components included in the Device(s) to be free of defects, the quality of workmanship, or the suitability of the premises for the Device(s).

THE INCENTIVES OFFERED UNDER THIS PROGRAM ARE INTENDED TO DEFRAID COSTS FOR IMPROVEMENTS AND HELP CUSTOMERS EFFICIENTLY USE RESOURCES. THE SFPUC DOES NOT GUARANTEE THE PERFORMANCE OR SUITABILITY OF ANY IRRIGATION CONTROLLERS, SOIL-MOISTURE SENSORS, OR ADD-ON DEVICES OR THAT THE INSTALLATION WILL BE FREE OF DEFECTS. THE SFPUC ALSO DOES NOT WARRANT THE QUALITY OF THE WORKMANSHIP OR SUITABILITY OF THE PREMISES FOR THE INSTALLATION, WHICH OCCURS IN A SEPARATE TRANSACTION. SFPUC'S SOLE OBLIGATION TO THE CUSTOMER UPON APPROVAL OF THE REBATE APPLICATION UNDER THIS PROGRAM IS THE AMOUNT OF THE REBATE OFFERED. THE APPLICANT FURTHER AGREES TO RELEASE AND HOLD HARMLESS THE SFPUC FROM ANY LOSS, DAMAGE, EXPENSE, OR LIABILITY RESULTING FROM THE LOSS, DESTRUCTION OF, OR DAMAGE TO PROPERTY ARISING OUT OF OR IN ANY WAY CONNECTED WITH THE INSTALLATION OF IRRIGATION CONTROLLER(S) OR CISTERN.
